The member introductions at the start of the meeting demonstrated the extent of involvement being conducted and the need to have this recorded and shared.



There is a need to track CS involvement: involvement requests received, member interest and applications, member involvement, member satisfaction and outcomes achieved.

Action: KM to meet with Kevin James to discuss how to raise the profile of strategic mental health involvement requests through the CS.

Action: Future CS Meeting to revisit PIFU and its implementation and achieved outcomes.

TF to provide an update at the October 2022 CS Meeting.

Action: KM to connect with David Huxter regarding Primary Care Networks/GPs and their requirement for Shared Decision-Making.

DH attended his surgery patient participation group meeting, the first for some time, he hopes that Shared Decision making will be discussed at the next PPG meeting.

Action: GD to arrange a Zoom meeting with Claire Uwins and Kevin James and other members with interest in Health Equity and Mental Health.

Action: KM to progress CS partnership with East of England Healthwatch and local Healthwatch to inform CS of the Healthwatch involvement with the Integrated Care Systems.

KM will be informing the East of England Healthwatch Forum the CS offering at their next Forum on Thursday 25th August 2022.

Action: KM/GD to investigate including on the CS Agenda the Directed Enhanced Service - the new contracts for doctors – access to personalised services, good customer service & communication skills, equality & diversity.

Action: Sharon Rodie agreed to return to share progress of the Suffolk and North East Essex (SNEE) Integrated Care System Integrated Care Strategy with the CS.

Action: KM to arrange co-production meetings with each of the Integrated Care Systems to support implementation, evaluation and consistency of co-production across the Region.



GD/KM had an initial meeting with senior staff regarding co-production and consistency of patient and public involvement across the East of England. We had representation from health, local authorities and health providers from Mid and South Essex (MSE) Integrated Care Board, Hertfordshire and West Essex (HWE) Integrated Care Board, North and Suffolk and North East Essex Integrated Care System.

CITIZENS' SENATE UPDATE

- KM shared the proposal for the Citizen' Senate Theme for 2022/23 on access to health and social care services considering health equity and the social determinants of health, data analytics (evidence) and workforce.
- KM emphasised the need to focus CS activity on Patient/Carer (CS Member) Involvement in strategic partnerships to be involved in priority setting and strategic coproduction to provide the patient/carer perspective and training in co-production principles.
- KM shared about the recent connection with Thriving Communities East of England part of the National Academy for Social Prescribing <u>https://socialprescribingacademy.org.uk/thriving-communities/east-of-england/</u>
- KM shared the desire to increase accessibility of the CS to support increasing the membership and to share this with its network. The CS, along with the Integrated Cares Systems, Healthwatch and other PPI Forums covers health and social care and
- KM updated on the work being done to obtain member's profile information. The website search engine is now more effective at being able to select Cs Members with specific experience/criteria to support external parties to have confidence of the diversity of lived experience of members.

Action: KM/GD to progress the 2022/23 theme, the engagement of strategic community partners and to access strategic co-production involvement requests.

WINTER PRESSURES

A vibrant discussion was had regarding the expected pressures on health and social care systems and the dangers of the predicted increases in fuel prices and the cost of living.
